At **Calvert**, Steve led the analyst team on various fund strategies, and he designed the firm's process for incorporating environmental, social and governance (ESG) information with equity valuation models and investment themes.

Previously, with **Credit Suisse AG's** global private bank, Steve served as deputy head of Americas Equity Research covering the Technology, Media and Telecommunications sectors. He also coordinated global and cross-sector research products, oversaw the New York team's investment process, and managed the group's talent development program.

Prior experiences include serving as the lead sell-side growth stock analyst with **CIBC Oppenheimer**, and an equity portfolio strategist at **Lehman Brothers**.

In addition to Steve's extensive professional experience, he is currently an adjunct professor at the **Kogod Business School at American University** in Washington, DC, where he teaches an online graduate-level course in accounting and finance.

Steve earned a B.A. from **Colgate University** in 1989 with a double major in Economics and Political Science. He earned his MBA from the **Darden Graduate School of Business Administration at the University of Virginia** in 1995. Steve is a Chartered Financial Analyst charter holder (CFA), and he has earned the Chartered Alternative Investment Analyst certification (CAIA).
